The Blue Book from the border is a documentary project based on several diaries held by young lawyers working in the refugee camps at the Macedonian borders during the refugee crisis as a result of the Sirian war in 2016–2017. The selected material follows crucial events during the two-year migrant crisis.

The diaries consisted of only fragmented handwritten material, so we had a mission to generate as much visuality as possible to create a unified and relevant document. In addition, while reading the diaries, we located a few completed stories and other short but important happenings that outlined the destinies of several people from their arrival till their departure from the camps. Consequently, we grouped the stories and comprised the book of five intertwined materials: photographs, scans of actual documents, video stills, text, and drawings. Thus some of the reports can be followed through drawings, others through photos or scanned documents, and through a purely textual form.

One of the challenges we were given by MYLA was to follow the law to protect the personal information of all the people mentioned and photographed that confirmation for their data usage was not given. Therefore, finding a visual solution to protect this information in the graphic design work was necessary. Thus, our solution was to use several graphical methods like drawing interpretation, photo blurring, and stenography.

In 2018 we were invited to design the catalog for the Macedonian Pavilion at the International Architecture Biennale in Venice 2018. The topic of the Pavillion was *Freeingspace* and was curated by the architectural duo Slobodan Veleviski and Marija Mano Velevska, and the exhibition consisted of four projects made by four young architectural teams. They represented several architectural analyzes dealing with the usurpation of the free public space in Skopje due to lousy urbanism and bad politics.

The material for the catalog contains all four projects, texts, timelines, interviews, and photographs, and our task was to put all these versatile materials together. For that purpose, we treated every material differently. However, our imperative was to emphasize the page's space (including the cover) as another element of our design, thus referring to the topic of Freeingspace.

The cover design is made by digitalizing and manipulating a handmade charcoal drawing. In 2019 the catalog was published in a second edition, for which we slightly redesigned the cover to create an effect of an animation frame implying the second edition.

The notebook is organized into 12 sections representing 12 months. Every month is represented by a digital drawing depicting a physical obstacle that must be overcome. At the same time, on every recto page, there is a drawing of a tiny human figure moving, creating a flipbook effect.

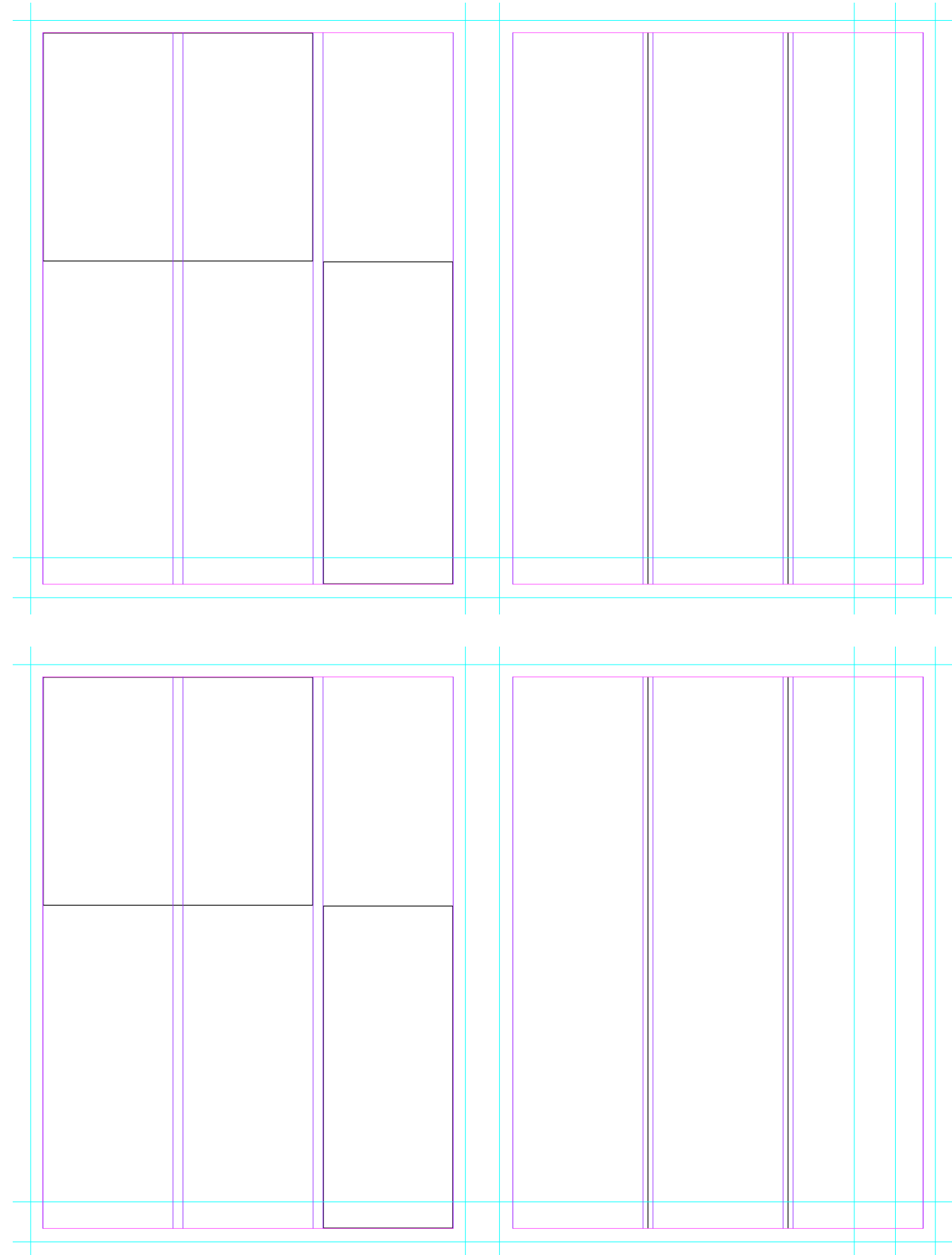

The journal *The Large Glass* is our long-lasting collaboration project with the Museum of Contemporary Art – Skopje. It is an annual journal for contemporary art, culture, and theory, and it comprises essays, visual essays, interviews, and exhibition reviews. The journal has a more extended history, but after a long time gap, it began to be published again. In 2018 the Museum decided to renew the journal and invited us to do the redesign. We have been working on its annual issue ever since.

The page layout was our starting point and a definer for the design of the whole journal. It is designed as an open modular system responding to all materials. It follows a grid system and color separators that adapt to the material and divide it according to the genres and the text-to-image ratio.

The feministic online platform Medusa, traditionally, every year, publishes a book with a collection of texts on topics regarding feminism and activism. Our studio was asked to design their second book with the theme *Beyond Resilience*.

In devising the theme, we decided to take women's dyed hair as a symbol of resilience, and then for our design. We intended to achieve a book design that would simultaneously resemble a hair dye product but is packed with feminist activist content. Therefore, a photograph of a woman's long and dyed hair repeats throughout the book as the title of every chapter. Additionally, colorful typography and visualizations fulfill the idea that comes from the primary visual motive.

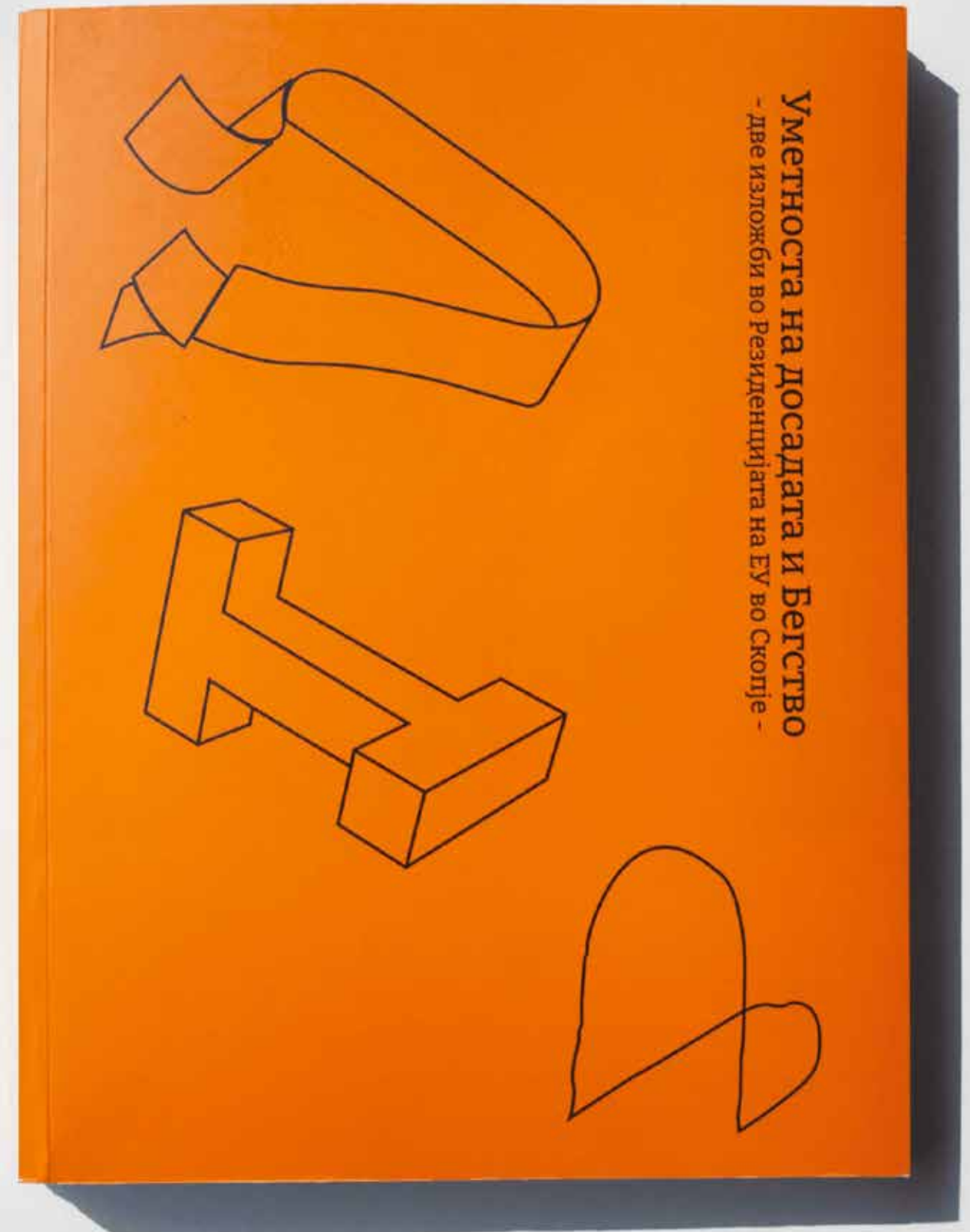

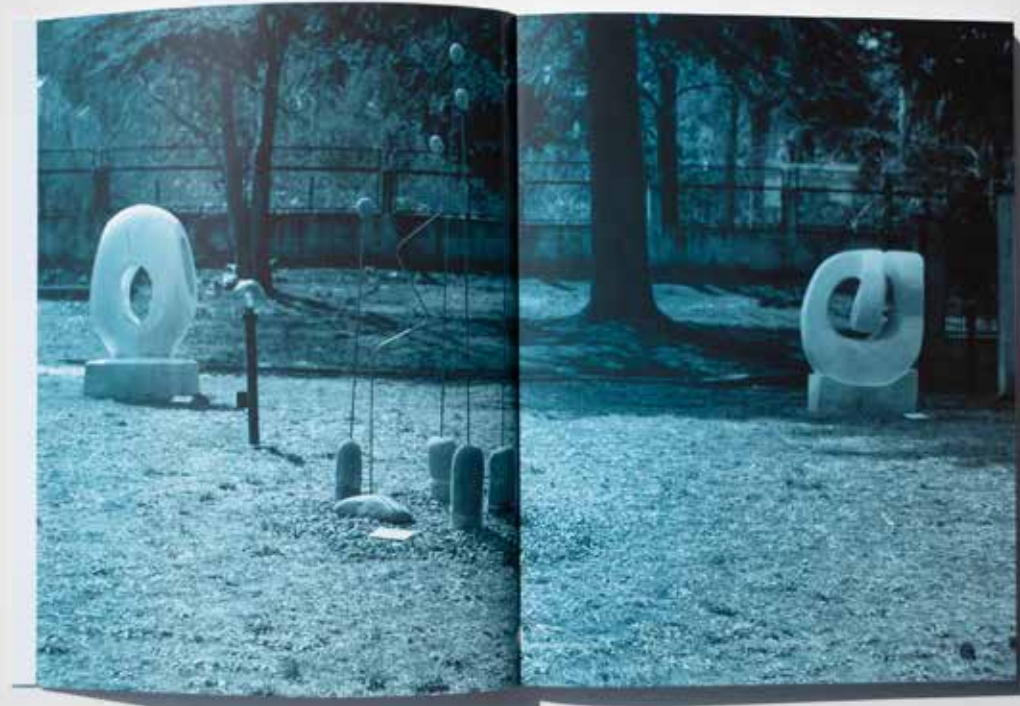

The Art of Boredom and Escape is a catalog for two exhibitions curated by Dijana Tomikj Radevska and organized by the Acanthus Gallery. The exhibitions were set at the European Union residence in Skopje, featuring works by different generations of artists from North Macedonia.

The curatorial statement referred to the pandemic of COVID-19 and the position of the artists in a time of closed cultural institutions and lack of support. That is why boredom and escape were crucial topics in outlining the list of artists and selecting the artworks. For the design, we followed these curatorial principles and interpreted them in the direction of a DIY product book. We found a solid parallel between the curatorial statement and the concept of DIY. In the pandemic condition, the artists were in a position to do their artwork by themselves, for themselves. Accordingly, we implemented the simplicity of traced linear drawings of sculptures featured in the exhibitions and the plain bare backgrounds colors. Additionally, the artists are presented separately with the same number of pages each.





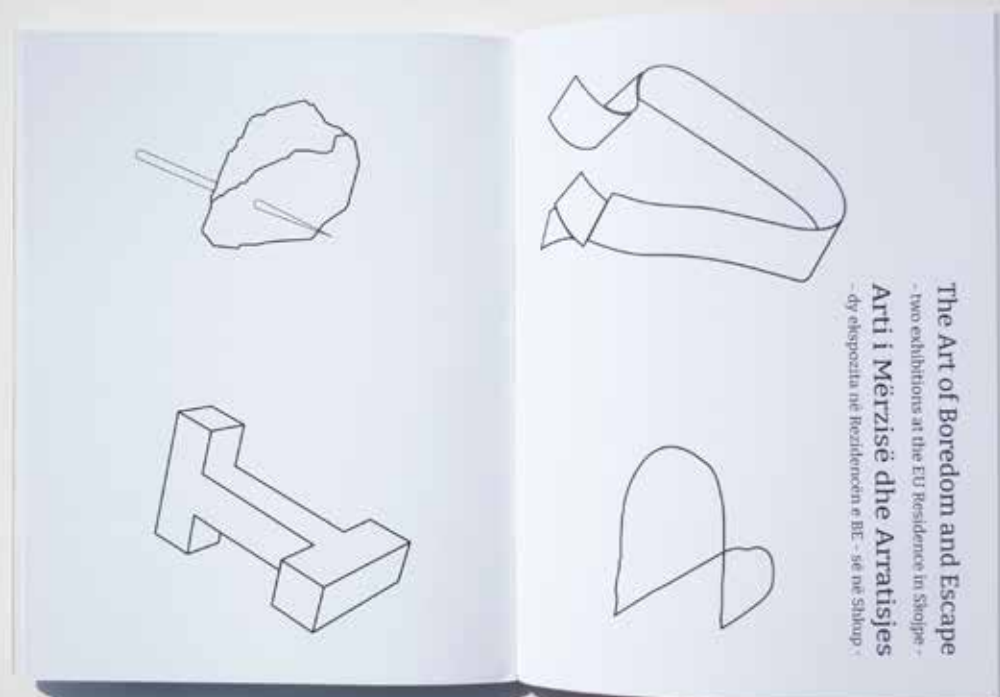

Our Paths: 25 Female Stories in History is a guide through trails trodden by women who participated in the historical courses on the geography of North Macedonia. This Guide presents 25 women's portraits and places, creating a map of important places and events that are formative for the contemporary tendencies in society.

The book's design (the page layout and the cover) refers to the famous traditional woven rugs from the Balkan region, a tradition inherent to women's work in this area. Additionally, the creation of the carpet carries a symbolism of creating and marking territory. The drawings on the cover are modifications of existing patterns from old Macedonian carpets. While the grid system in the page layout suggests a loom, a device for weaving textiles. Thus, each page is defined by three straight vertical lines that define the space where the text and visual material are placed.

Занитересирајќи се не е ништо поголема ци за седниците на советот, кои се отворени за јавноста. Ретки исклучоци се седниците на кои се дискутира прашање кое е по-суштински присутно во јавниот дискурс. Такви е примерот со прашањето за локалните референдуми против отворањето рудници на територијата на некои од општините. Вработена во општинската администрација во Дојран, на пример, истакна дека иако за сите седници на советот исто се информира, за разлика од другите седници, таа на која се дискутира прашањето за референдумот имала значително присуство на занитересирани граѓани.

Комуникацијата на општините со граѓаните е предмет на посебен дел од оваа анализа. Но, она што треба да се спомене овде е и улогата што ја играат месните и урбаните заедници во пренесувањето информации до граѓаните и организирањето различни јавни дискусии.

Месни и урбани заедници

Важна тема која се наметна во сите фокус-групи, во секoja од општините, е функционирањето на месните и урбаните заедници. Како што е споменато во анализата на правната рамка, Законот за локална самоуправа предвидува можност да основање на облици на месна самоуправа, и тоа урбани заедници во градовите и месни заедници до другиот населени места. Облиците на месна самоуправа, нивната врска со општинските органи и прашањата кои се во надлежност на општината, а може да бидат делегирани на раководството на месната самоуправа се уредени со статутите на општините. The brand design for PrivatePrint is more than a design. We are PrivatePrint, and here we show the philosophy behind our design practice. Since we primarily function as a publishing house, our expertise is based on our knowledge of books and editorials. Therefore our primary design interest is focused on books and typography design.

We developed the logo simultaneously with the development of the name PrivatePrint. The name by itself has an oxymoronic meaning. At the same time, it represents two opposite words in a collision. Since the purpose of the print is not to be private but to disseminate as a public commodity. Therefore, our intention with the connection of these two words with the help of irregular accents to the letters "P" was to create a binocular effect and an illusion of a new word that explains an artwork that is independent, outside of the established cultural institution, available, and easy to be disseminated.

The logo is constructed with a modification of several fonts where the letters "P" and the accents are two modular parts that can be used separately from the logo, depending on the purpose. The logo is designed in long and short forms, depending on its application.

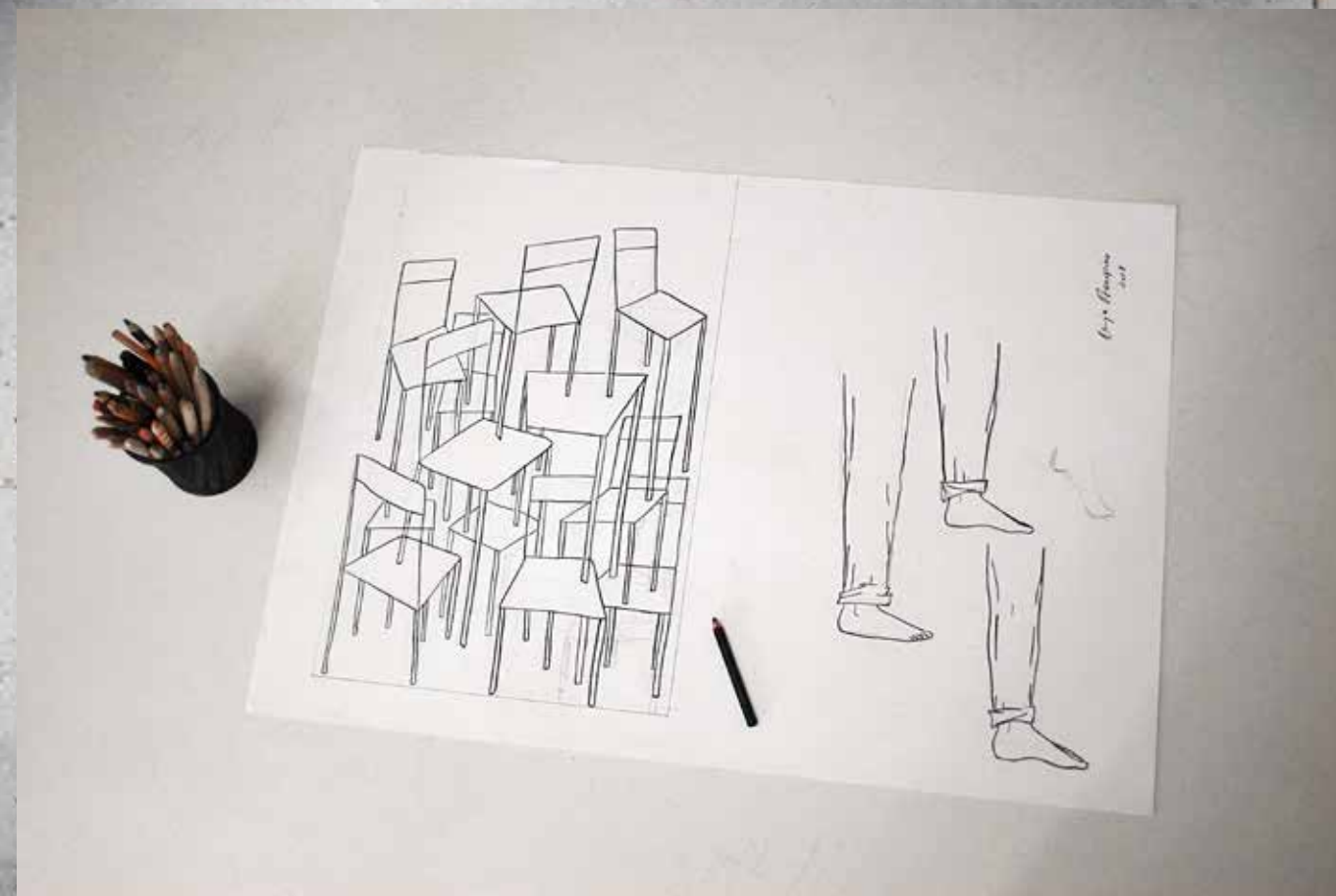

Am I Home? is a visual identity design for promotional materials for World Refugee Day, 20 June 2018. Project by Macedonian Young Lawyers Association and USAID Macedonia.

The starting point for the design was to present something that would lead to the idea of no man's space, which consists of elements of familiarity but simultaneously transforms those elements into objects of trauma. That is how we came to the motif of a pile of school chairs. The school is a symbol of possibilities and order. It gives us a feeling of home and security and the opportunity to envision our future. On the other side, when we become refugees, all these qualities become impossible, and to reach them is a constant search for a new home, walking through insecurity and lost dreams.

The design is made by digitalization and manipulation of a hand-made charcoal drawing. The drawing elements are treated translucently so an effect of fleetingness can be achieved.

FIRSTBORN GIRL #6

In 2018 we had the honor to design the visual identity for one of the most prominent festivals for feminist culture in North Macedonia, the *Firstborn Girl* #6. The focus of the 6th edition of the festival was women's labor rights, where the number 6 was taken as a symbol of commitment to a new 6-hour work-day. As the organizers of the festival said, "6 hours work, 6 hours culture, 6 hours activism, 6 hours rest" is the advocating postulate of the sixth edition of the feminist culture and action festival – FIRST BORN GIRL. Improving labor rights for women, proper valuation of our fellow citizens' unpaid housework, and finding paths of giving conscious resistance to the current and past forms of exploitation and devaluation of labor and dignity are issues that are the focus of this year's festival."

Taking this direction, we based our design on an image of protest as a symbol already part of our collective memory. The fight for labor rights is longer than a century. We fight today as we fought yesterday. Thus, the powerful image of the protest march is taken in the design to represent the continuous struggle for unity and solidarity for women and labor rights.

The design is made by digitalizing and manipulating a hand-made crayon drawing and lettering. The drawing represents rows of silhouettes of women figures, creating a composition that fulfills the rectangular (poster) space, giving a sense of movement. The elements from the poster, together or separately, were used for the festival program and social media.

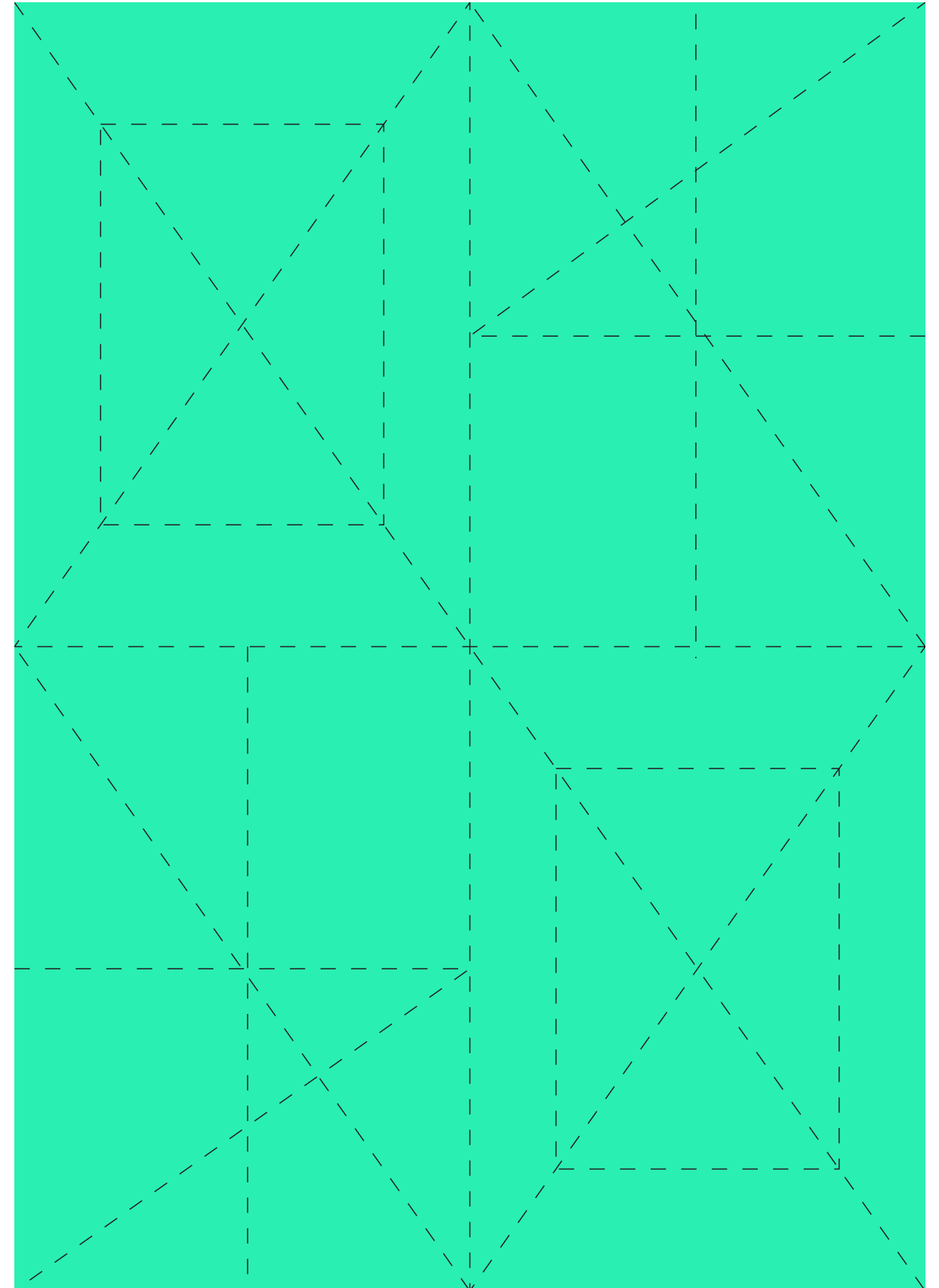

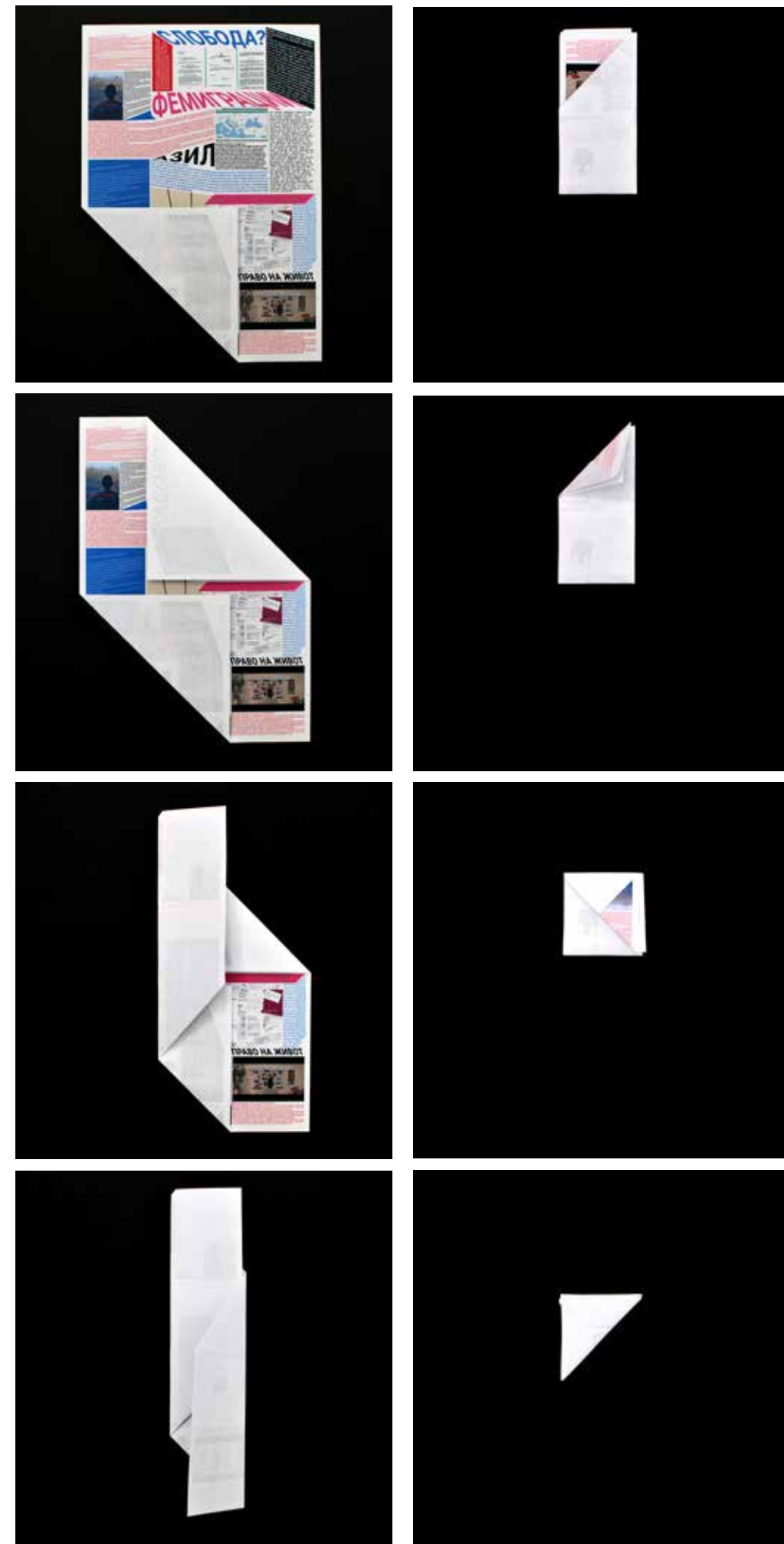

As a graphic design studio, we have been engaged several times to work on MYLA's multi-year project on the refugee crisis due to the war in Syria, 2016-2017. In addition to The Blue Book from the Border in 2018 and the Promotional Material for Refugee Day in 2018, we worked on two informational posters for the final project event in 2019.

The main task we were given by MYLA was the design of the posters to incorporate material generated during the 2 years project, including photographs, text, scans of documents, etc. This brief gave us directions that those posters were not meant to send single and fast information but to take time and to be read. This brings us to the idea of foldability and mobility. We decided that the posters could be detached from the wall, folded, and taken for reading as a pamphlet, so people would not stand for hours reading the full information from the attached poster on the wall but could take it and read it whenever and wherever.

Since the pieces of information on the posters are collaged, each has its own space that does not follow a rectangular shape but different geometrical shapes connected with typography and drawings. This implies a possibility of unorthodox poster folding (following the rectangular shape of the poster) but a more playful one.

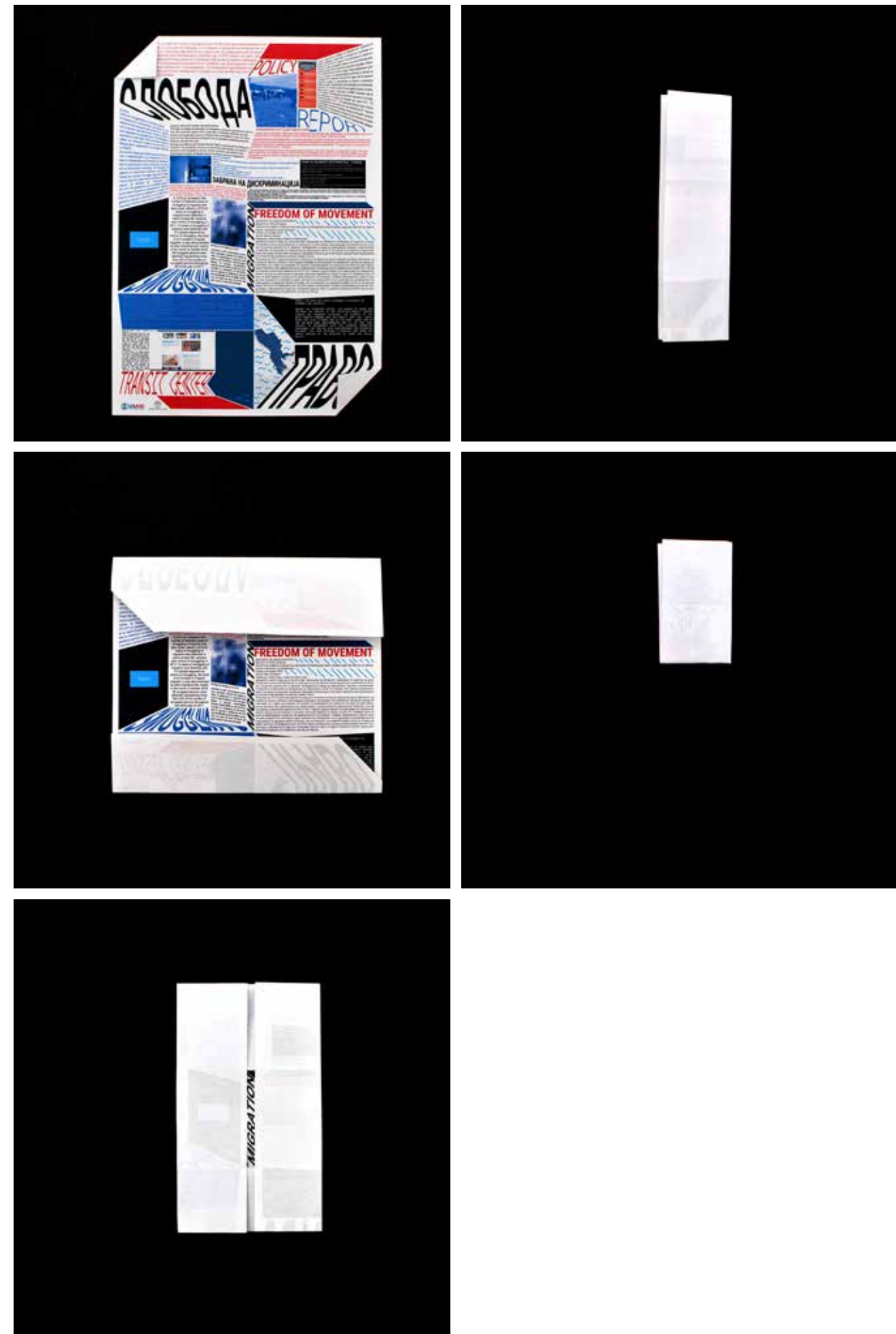

The engagement to design a poster for a movie festival dedicated to the 100th anniversary of Ingmar Bergman had a very significant meaning for us since we are great admirers of Bergman's movies.

One of the many things that always fascinated us in his films was his masterful talent for speaking to us through silence. Therefore, the scenography design from the movie *Cries and Whispers* (1972) was a focal point for the design. However, besides the interior aesthetic defined through the room scenes and the intensive red color, we wanted to add movement and the feeling of the previously mentioned loud silence as part of the design.

The design is made by digital drawings and organized into four sections, three resembling movie frames into a storyboard on which we see an interior of a room. In these frames, a narrative can be followed through the movement of the elements in the room, the curtain, the table, and the light.

The project *Elimination of Torture and Inhumane Treatment in Prisons and Detention Facilities*, led by the MYLA's team, was about improving conditions in Macedonian prisons. Through visits to prisons around the country and sessions with prisoners, the legal team aimed to inform and advise prisoners about their rights and ways to achieve them.

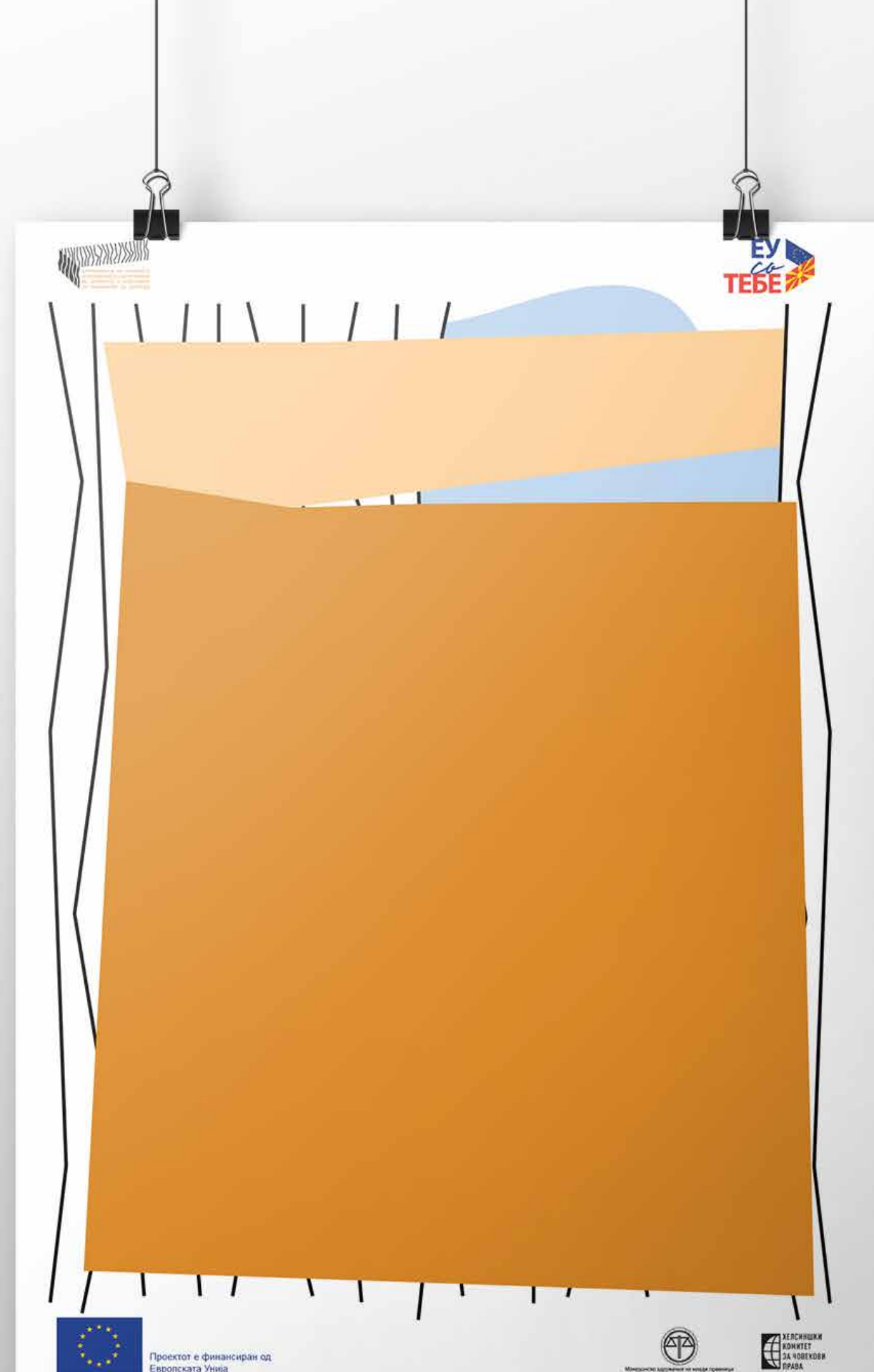
We were engaged in creating the project's visual identity to unify all the materials that will be used by the MYLA's team, intended to be shared with the prisoners and to promote their activities to the official institutions of the country.

First of all, our task was to design a logo and then develop the visual motif of the logo into a multipurpose application design. In addition, we worked on promotional material, posters, booklets, infographics, and presentations as part of the project.

For the visuals of the project's logo, we referred to the first association for the prison, which is the prison bars. The prison bars and the prison cell symbolize punishment through fear and inhumanity. So we tried to develop the idea of eliminating inhumane prison treatment by breaking that symbol and opening the cube shape that suggests opening a prison room, creating a sense of liberation.

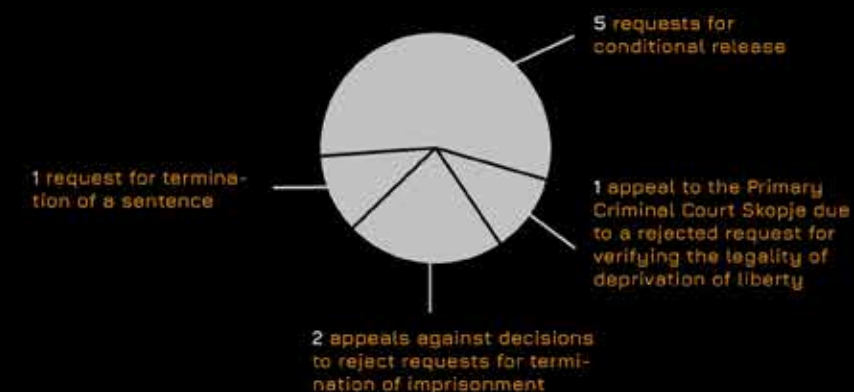

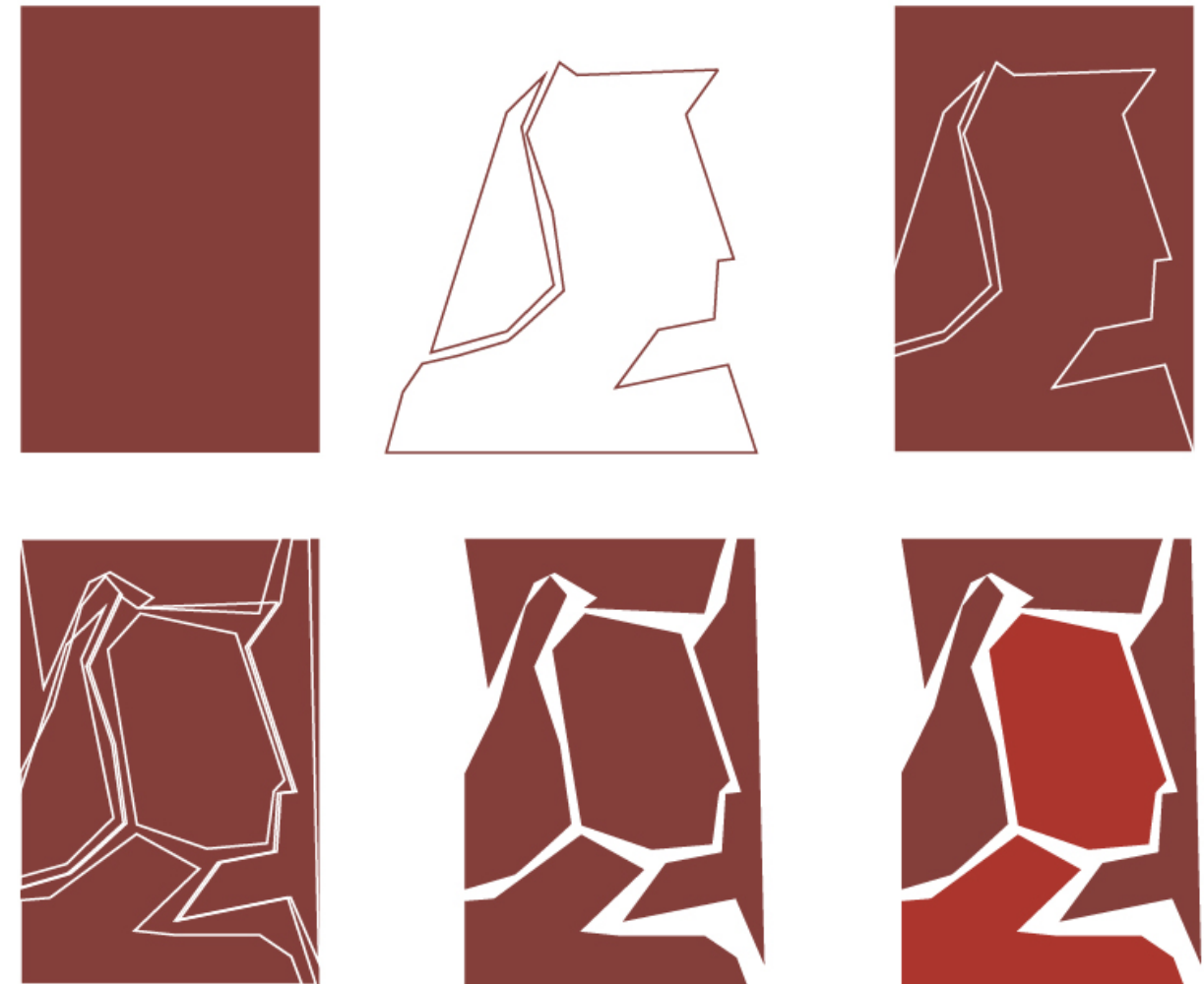

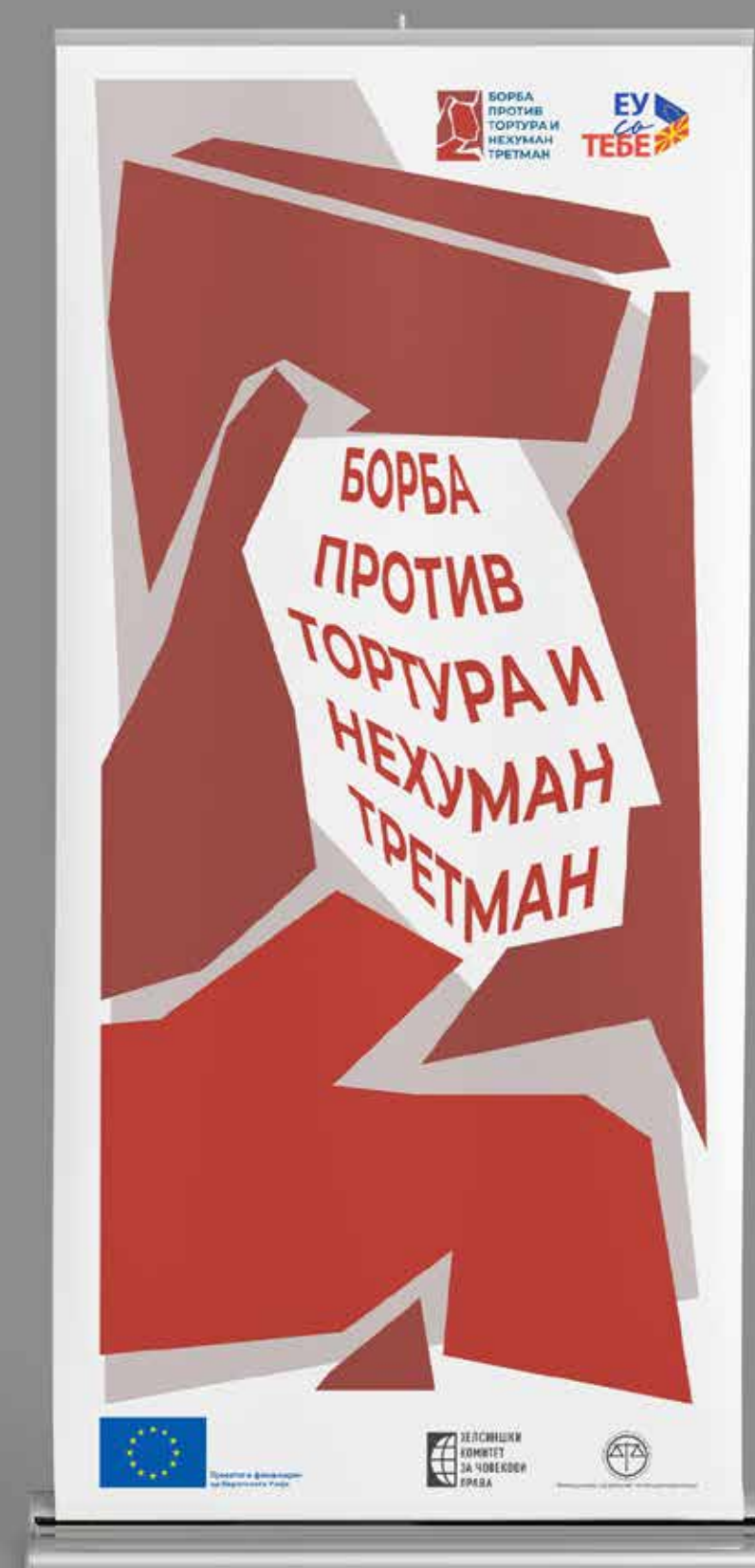
The *Fight Against Torture and Ill-Treatment* project, led by the Helsinki Committee for Human Rights team, is a two-year follow-up to the *Elimination of Torture and Inhumane Treatment in Prisons and Detention Facilities* project (see page 116), but with a focus on changing punishment laws such as and the introduction of psychiatric care in prisons or for prisoners.

Here, we were also engaged in creating the project's visual identity to unify all the materials that the Helsinki Committee for the Human Rights team will use, intended to be shared with the prisoners and to promote their activities to the official institutions of the country.

First of all, our task was to design a logo and then develop the visual motif of the logo into a multipurpose application design. In addition, we worked on promotional material, posters, booklets, infographics, and presentations as part of the project.

Unlike the first project about prisons, here we had the task of developing a logo design that would refer to a system change, or rather a humanization of the system in terms of the treatment of prisoners. So we decided to translate the process of creating a stone sculpture into the design idea for the logo to follow the symbolism of breaking a rigid form into a new humanized one.





INFOGRAPHIC FOR THE PERIOD FROM DECEMBER 2021 TO MAY 2022

Within the framework of the project "Fight Against Torture and Ill-Treatment", the Helsinki Committee for Human Rights and the Macedonian Young Lawyers Association conducted 3 regular visits to penitentiary institutions, namely in PI Kumanovo, PI Prison Skopje and in the open department of PI Idrizovo - Veles.



COURT PRACTICE

On May 30, 2022, the Basic Criminal Court of Skopje passed a verdict declaring the accused G.P., a uniformed police officer employed in the SIA Bitola, guilty and sentencing him to one year in prison for the crime of Mistreatment in performing a duty from Article 143 of the Criminal Code. The injured party was represented by a lawyer supported by the Helsinki Committee and the Macedonian Young Lawyers Association.

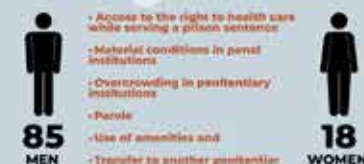

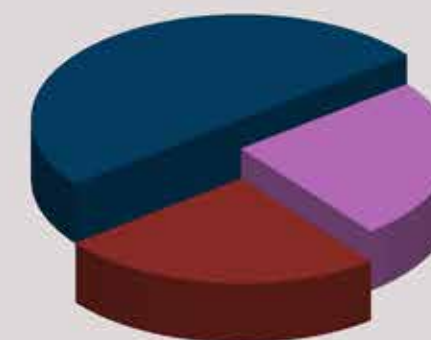

COURT AND INSTITUTIONAL PRACTICE FOR CASES REPRESENTED WITHIN THE PROJECT FRAMEWORK

OCTOBER

In October 2022, the Basic Criminal Court in Skopje issued a verdict which found that the police officers were guilty of the crime "Mistreatment in the performance of their duties" from Article 143 paragraph 1 c.c. 22 of the Criminal Code and imposed an alternative measure on them - a suspended sentence of an effective prison sentence of 1 year, which sentence will not be carried out if the defendants do not commit a new crime for a period of 3 years.

In October 2022, the Skopje Court of Appeal made a decision upholding the appeal of the convicted person and amending the decision of the criminal council of the Basic Criminal Court Skopje, which reads - the convicted person is released from serving a prison sentence, on condition that in the time for which the prison sentence was imposed to not commit a crime.

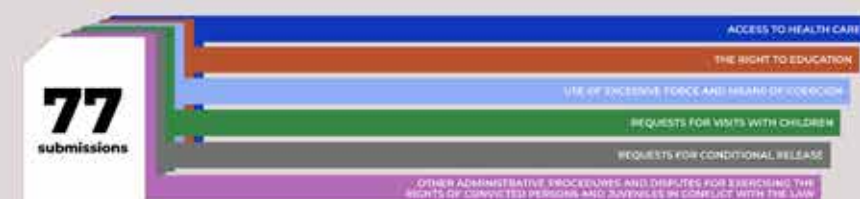
NOVEMBER

In November 2022, the Basic Criminal Court of Skopje issued a verdict respecting the proposal of PHI Psychiatric Hospital Skopje - Skopje to replace the measure - Mandatory psychiatric treatment in a psychiatric institution with the measure - Mandatory psychiatric treatment at liberty.

The Basic Criminal Court Skopje made a decision respecting the proposal of PHI Psychiatric Hospital Skopje - Skopje to replace the measure - Mandatory psychiatric treatment in a psychiatric institution to a Mandatory psychiatric treatment at liberty. This decision was made following a notification submitted by the Helsinki Committee for Human Rights to the court.

The Directorate for Execution of Sanctions accepted a complaint filed against a decision imposing solitary confinement for a period of 14 days without the right to work, and the case was sent back for re-decision before the PI Prison Skopje.

This diagram design was commissioned by the Architekturmuseum der TUM in Munich for their exhibition called The Gift. It represented data and archival material in a timeline to represent the humanitarian gifts in Skopje after the 1963 earthquake.

This exhibition itself featured gift-ed buildings—from spectacular to mundane, from extravagant to genuinely useful. These include stories of humanitarian gifts for Skopje, North Macedonia; the gift of land in Kumasi, Ghana; diplomatic gifts for Ulaanbaatar, Mongolia; and philanthropic gifts in East Palo Alto, California, USA. At the end of the exhibition, we turn to Germany, showing how philanthropy continues to shape Munich and other German cities today.

The design included visual data representation on the basis of archival booklets “Your Aid to Skopje” where all aid for Skopje was listed, visual timeline representation of the aid and diplomatic visits in Skopje.
